Chairperson Jaclyn Chancey called the meeting to order at 6:31 PM. Members present were Eugene Boomer, Amy Ouimette, and William Hooper at 6:54 pm. Administrators present were Superintendent Ken Henrici and Principal Patricia King.

- 3. Presentation of CAPSS Student Leader Award** – Superintendent Ken Henrici, Principal Patricia King and Chairperson Jaclyn Chancey presented Haley Scanlon and Zachary Tabor with the CAPSS Student Leader Award.
- 4. Presentation of CMT Science Student Awards** – Superintendent Ken Henrici, Principal Patricia King and Chairperson Jaclyn Chancey presented Aidan Charland, Ashlyn Kemp, Charley Bennett, Haley Scanlon, Kaelyn Pearl, Liam Quinn, Nicholas St. Dennis, Nickolas Hovey, Oskar Mieloch, William Smith and Zachary Tabor with the CMT Science Student Award.
- 5. Approval of Minutes and Financial Statement**
 - A. Approval of Minutes – September 13, 2017** – Eugene Boomer moved to approve the September 13, 2017 with the following amendment; “the meeting to order at 6:30 pm,” instead of the “the meeting to order at 6:3pm.” Amy Ouimette seconded and the motion passed unanimously.
 - B. Approval of Financial Statement – September and October 2017** – William Hooper moved to approve the September and October 2017 Financial Statements. Eugene Boomer seconded and the motion passed unanimously.
- 6. Administrative Reports**
 - A. Monthly Report** – Nila Otilige CEA president welcomed the new board members to the board and spoke to them on the new social and emotional learning program being implemented in preK through 4th grade. She also spoke highly of the new math program that is being implemented into the school.
 - B. Principal’s Report** – Principal Patricia King welcomed the new board members to the board and reviewed with them the upcoming professional development and training days that are coming up. She also reviewed the upcoming academic events including the end of the first marking period with report cards being issued November 20th and parent teacher conferences happening November 20th-21st. She also informed the board of the School Readiness Council meeting that happened on September 26th and that the next meeting would be November 28th. Principal Patricia King also reported back to the board about the recent Time Capsule Celebration that happened on November 1st, the Helping Hands Food Drive/Spirit Week that was happening at the school November 13th-17th, the upcoming Muffins with Mom that will be happening on November 17th and finally the Annual PTO craft fair that will be taking place December 2nd. Lastly she updated the board on the operations of the school including the purchase of three salvaged computer servers and document cameras from UCONN Surplus, updating I-pads in the school, and pest abatement is in process.
 - C. Superintendent’s Report-** Superintendent Ken Henrici welcomed Eugene Boomer, Daniel Caron, Amy

Ouimette, and Jean Lambert to the Chaplin Board of Education and thanked Stephanie Harrington, John Bolduc and Stacy Foster for their years of service to the board. He reviewed the final ECS Allocations for Chaplin to the board and informed them that in in Fiscal Year(FY) 2017 the town will receive \$1,856,992.00, FY 2018 it will be reduced by \$92,850.00 and in FY 2019 it will be reduced by \$19,302.00. He reminded the board that the Addition/Withdrawal of Grades Committee’s Public Hearings and Referendum will be held on November 16th. He updated the board on the recent “Coffee And” Meetings with the Superintendent that happened in October and informed them that the next one is planned for December. Lastly he informed the board that the 2016-2017 Budget Deficit of \$236,000.00 has gone to the Board of Finance and once they vote on it, they will send it on to the Board of Selectman and then a Town Meeting will be set.
